3 SECTION 1. SHORT TITLE.
4 This Act may be cited as the "Safeguarding the Use
5 of the National Guard Act" or the "SUN Act".
6 SEC. 2. CONGRESSIONAL OVERSIGHT OF DOMESTIC USE OF

8 (a) In General.—Except as provided in subsection

9 (b), not later than 15 days after the date on which the

tional Guard at a location in the United States pursuant 2 to chapter 13 or 15 of title 10, United States Code, or 3 any other law or authority, the President shall submit to 4 Congress a report on the use or deployment that in-5 cludes— 6 (1) the precise legal basis and goals of the 7 President for the deployment or other use, including 8 any evidence substantiating the assessment of the 9 President; 10 (2) a description of the effect of such deploy-11 ment or use on any situation identified in such jus-12 tification, including any specific reports of any inter-13 actions between members of the National Guard and 14 civilians engaged in violence or threats of violence; 15 (3) reports from local and State law enforce-16 ment agencies describing any such interactions, in-17 cluding the extent of actual violence or threat of vio-18 lence, and the assessment of such agencies of the 19 propriety of deployment or other use of members of 20 the National Guard; 21 (4) an estimate of the total cost to the Federal 22 Government for the entirety of the deployment or 23 use, including any indirect costs to the Department

1 (5) a certification that such deployment or use 2 of the members of the National Guard will not inter-3 fere with the ability of the Armed Forces to respond 4 in the event of a disaster that could be covered by 5 a presidential declaration under the Robert T. Staf-6 ford Disaster Relief and Emergency Assistance Act 7 (42 U.S.C. 5121 et seq.). 8 (b) EXCEPTION.—Subsection (a) shall not apply with respect to the use or deployment of members of the Na-10 tional Guard at a location in the United States pursuant 11 to a presidential declaration under the Robert T. Stafford 12 Disaster Relief and Emergency Assistance Act (42 U.S.C. 13 5121 et seq.) in response to a natural disaster or other 14 weather-related event.
